



## **Capture the Golden Penguin Competition 2019**

### **Promotion Specific Terms of Reference**

This Promotion is open to all Jersey and Guernsey residents aged sixteen (16) and over (except for employees of JT) who elect to be entered into a prize draw for the chance to win ten (10) free ice skating tickets by accepting these terms of reference and providing JT with information via its social media pages (each an “Entrant” and together the “Entrants”). As part of its Christmas 2019 marketing campaign, JT is to publish an animated GIF on its Facebook and Instagram social media pages called “Screenshot the Golden Penguin” in which a gold-coloured penguin will appear (the “Golden Penguin”).

#### **PROMOTER**

1. The promoter of this Promotion is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (“JT”).

#### **THE PROMOTION**

2. This Promotion involves the chance to win ten (10) free tickets to:
  - 2.1 ‘Ice Skate Guernsey’ which takes place at La Friquet Garden Centre from 7 December 2019 to 5 January 2020; or
  - 2.2 ‘Ice Skate Jersey’ which takes place at Fort Regent from 6 December 2019 to 5 January 2020.
3. In order to enter, each Entrant must have a valid social media account with either Facebook or Instagram and visit either the JTSocial Facebook ([www.facebook.com/JTSocial](http://www.facebook.com/JTSocial)) or the JTSocial Instagram ([www.instagram.com/JTSocial](http://www.instagram.com/JTSocial)) social media pages between 14 November 2019 and 5 December 2019 (the “Promotion Period”) and complete all of the following steps:
  - 3.1 “Like” the JTSocial Facebook page or “Follow” the JTSocial Instagram page;
  - 3.2 Take a picture of the Golden Penguin when it is on screen and “post” that photo to either or both of their Facebook and/or Instagram social media pages;
  - 3.3 Include the “Tag” “@JTSocial” when posting the photo; AND
  - 3.4 “Tag” at least three (3) friends when positing the photo.
4. JT will draw one (1) winner from each island (Jersey and Guernsey) at random from all valid entries by midday on 10 December 2019 (the “Draw”) and the two (2) winners will each receive ten (10) free Ice-Skating tickets to Jersey or Guernsey (the “Tickets”).
5. Entrants that have not completed each of the required four (4) steps set out at 3.1-3.4 above, shall not be eligible to be entered into the Draw.

6. The Tickets are non-transferable and non-refundable and the winners cannot receive cash, or an alternative item, in place of the Tickets.
7. Use of the Tickets is subject to Ice Skate Guernsey or Ice Skate Jersey terms and conditions, and JT shall not be responsible for any action taken by Ice Skate Guernsey or Ice Skate Jersey in this respect.

#### GENERAL

8. No purchase of any sort is necessary to enter this Promotion and there is no charge to enter.
9. All posts and comments on Facebook and Instagram must be made in accordance with Facebook's and Instagram's respective terms and policies. JT shall be entitled, at its sole discretion, to disqualify any Entrant acting in breach of those terms.
10. The winners shall be contacted via the Facebook or Instagram account provided as part of the online entry pursuant to the terms of clause 3 above. JT shall make all reasonable efforts to contact the winners, but if any winner does not respond to notification from JT within two (2) days, then JT reserves the right to select a new winner at random.
11. A winning claim is subject to a full verification process and the Tickets may not be claimed without valid confirmation by JT as to the identity of the winners of the Tickets. The decision of JT as to who has won the Tickets is final.
12. By entering this Promotion, each Entrant agrees that the winners' names and photographs taken whilst collecting the Tickets may be used by JT for reasonable publicity purposes in connection with this Promotion.
